If you decide not to have your child use this program, please indicate that you wish to **opt out**, sign and return the last page of this document. Then one of the other options described above may be utilized. Your choice will in no way impact the education that your child receives. All students will have access to the same educational resources. We have made significant efforts to ensure that there are a variety of options available so that students will not be at a disadvantage based on their selection.
